- 6. The Employer hereby covenants to pay the Contractor, in consideration of the execution and completion of the Works and the remedying of defects therein, the Contract Price at the times and in the manner prescribed by the Contract.
- 7. The Contract Shall come into full force and effect on the date last signed by a party.
